Dear Mr. Stogner:

Our law firm represents Humboldt Redwood Company, LLC ("HRC"). HRC is the successor in interest to certain real property previously owned by The Pacific Lumber Company ("PALCO") AND Britt Lumber Co., Inc. ("Britt").

On December 5, 1990 PALCO and Britt entered into the enclosed agreement with The Eureka Southern Railroad and The Northwestern Pacific Railroad Acquisition Corp. (collectively, "the Railroad") ("the Agreement"). Also enclosed is a "Memorandum of Agreement" recorded on January 31, 1991, in the Official Records of Humboldt County as document 1991-2323-5, for the purpose of imparting notice of the Agreement.

Pursuant to Paragraph 4 of the Agreement, for a period of 50 years, commencing on December 5, 1990, the "Railroad grants to PALCO and Britt, individually, or their successors in interest, an option to purchase in fee any or all portions of the Railroad 'right-of-way' which are located adjacent to real property owned by PALCO or Britt" ("Right-of-Way").

Paragraph 4 of the Agreement also provides that the option may be exercised by PALCO "no later that 180 days of the date the Railroad or its successor's in interest fail to operate or maintain said railroad operations on said 'right-of-way by giving Railroad or its successors in interest written notice." The Agreement additionally provides that "within 30 days of the date of said written notice PALCO shall pay Railroad or its

successor in interest the sum of \$20,000.00 cash as payment in full of said real property subject to this option regardless of whether PALCO or Britt or both exercise said option to acquire any or all of the real property subject to this option."

This letter shall serve as formal notice to North Coast Railroad Authority, as the successor in interest to the Railroad, that upon approval by the Surface Transportation Board of your application to abandon the rail line, HRC hereby exercises its option to purchase in fee all portions of the Right-of-Way that are adjacent to its lands. HRC is prepared to immediately deposit into an escrow the \$20,000.00 payment for said real property in accordance with the terms of the Agreement.

I shall be contacting you in the very near future regarding the payment and the logistics of finalizing the transaction. Please do not hesitate to contact me if you care to discuss the matter. Thank you.

AGREEMENT

This agreement is made December 5, 1990, by and between The **Pacific Lumber Company** (PALCO), a Delaware corporation, **Britt Lumber Co.**, **Inc.**, (Britt), a California corporation, and The Eureka Southern Railroad, a California corporation, and **The Northwestern Pacific Railroad Acquisition Corp.**, a California corporation (jointly the Railroad), and is based upon the following mutually agreed upon facts:

A. PALCO is a timber growing and lumber manufacturing concern owning in fee approximately 200,000 acres of timberland situated in Humboldt County, California.

B. Britt is a lumber manufacturer located in Humboldt County, California.

C. The Railroad operates a rail line which generally runs from Eureka, Humboldt County, California, through Trinity County, California, and terminates at Willits, Mendocino County, California. The "right-of-way" upon which said railroad line is located will be described and attached hereto as **Exhibit A** and will be incorporated herein by this reference subsequent to the execution of this agreement and represents the entire railroad right-of-way located in Humboldt County, Trinity County and Mendocino County, California. Failure to create and attach Exhibit A will not invalidate this agreement.

D. On or about December 16, 1986 the Railroad sought protection from its creditors by filing a bankruptcy petition seeking reorganization. Said petition was filed in the United States Bankruptcy Court for the Northern District of California. The Railroad is currently managed by a bankruptcy trustee under supervision of the Bankruptcy Court.

E. The Railroad's predecessors in interest constructed Railroad's track over said "right-of-way" which was granted in part by PALCO's predecessors in interest and by Britt or Britt's predecessor in interest. In each case the grantor granted Railroad's predecessors a fee interest in said "right-of-way", retaining a right of reverter to said "right-of-way" which would cause fee ownership to revert to grantors or their successors in interest if and when the grantee(s) or their successors in interest failed to operate and maintain a railroad line on said "right-of-way".

F. The aforesaid "right-of-way" is 66 feet wide in most locations but is wider in some and narrower in some. This agreement pertains to all of Railroad's "right-of-way", regardless of width. For the purposes of this agreement the term "right-of-way" means all Railroad ownership located in the Counties of Humboldt, Trinity and Mendocino, California.

G. Timber, some currently merchantable and some currently unmerchantable, stands and lies on said Railroad "right-of-way".

H. Railroad desires to sell, and PALCO desires to buy, timber rights forever and not merely the standing timber located on the aforementioned Railroad "right-of-way".

I. PALCO and Britt desire to acquire an option to purchase those portions of the aforesaid Railroad "right-of-way" which are located adjacent to real property owned by PALCO or Britt, respectively.

J. As consideration for the aforementioned timber rights^{*} and for Railroad's grant of an option allowing PALCO and Britt to purchase a portion of the aforesaid "right-of-way" which is adjacent to PALCO or Britt's real property, respectively, PALCO will pay to Railroad the sum of \$180,000.00 cash.

NOW, THEREFORE, in consideration of the mutual promises contained herein, the parties agree as follows:

1. An escrow will be opened at Fidelity National Title Insurance Company located at 404 Fourth Street, Eureka, California.

2. Railroad shall convey to PALCO by deed the timber rights to timber located within the railroad "right-of-way" located in Humboldt, Trinity and Mendocino Counties. Said deed shall grant to PALCO all timber standing, lying or being on said railroad "right-of-way" and timber rights forever, not merely the timber presently standing on said real property and shall include the right to manage, cut and remove timber from said "right-of-way". Said timber rights conveyed shall be free of liens.

3. PALCO or any successor in interest shall not interfere with the Railroad's operation of its rail line in any way that would affect Interstate Commerce, and agrees that Railroad will be notified of any logging operation prior to its commencement so that appropriate measures may be taken by Railroad for its continued operation.

4. For a period of 50 years, commencing on December 5, 1990, ATTORNEYS AT LAW 550 -1- STREET POST OFFICE BOX 23 EUREKA, CALIFORNIA 95502 Railroad grants to PALCO and Britt, individually, or their successors in interest an option to purchase any or all of the portions of the Railroad rightof-way which are located adjacent to real property owned by PALCO or Britt. The purchase price shall be \$20,000.00 payable in cash. Said option may be exercised by PALCO or Britt or both or their successors in interest if in the future Railroad or its successors in interest fail to operate and maintain a railroad operation on said "right-of-way". Said option may be exercised by PALCO or Britt or both no later than 180 days of the date Railroad or its successors in interest fail to operate and maintain a railroad operation on said "right-of-way". Said option may be exercised by PALCO or Britt or both no later than 180 days of the date Railroad or its successors in interest fail to operate or maintain said railroad operations on said "right-of-way" by giving Railroad or its successors in interest written notice. Within 30 days of the date of said written notice PALCO shall pay Railroad or its successors in interest the sum of \$20,000.00 cash as payment in full for said real property subject to this option regardless of whether PALCO or Britt or both exercise said option to acquire any or all of the real property subject to this option.

5. PALCO shall pay Railroad \$180,000.00 on the terms and conditions set forth herein.

6. This transaction is expressly contingent upon approval of this agreement and written court order stating said approval by the United States Bankruptcy Court for the Northern District of California.

7. PALCO shall pay to Railroad the sum of \$40,000.00 cash upon the filing of the aforesaid court order of the Bankruptcy Court. An additional \$60,000.00 shall be paid to Railroad no later than 11:00 a.m. December 7, 1990. The sum of \$80,000.00 shall be deposited in the aforesaid escrow to be released to Railroad upon the issuance of a California Land Title Association standard policy of insurance in the amount of \$165,000.00 to be paid by PALCO and to be issued by Fidelity National Title Insurance Company showing title to the aforementioned timber rights in the name of PALCO. In no event shall the \$80,000.00 be paid to Railroad later than 30 days from the date of this agreement.

8. PALCO shall have the right to further assign or convey said timber rights being acquired from Railroad.

9. This agreement shall be binding on and inure to the benefit of the parties to this agreement and their successors and assigns.

MEMORANDUM OF AGREEMENT

By this Memorandum of Agreement Eureka Southern Railroad Co., Inc.,, a California corporation, and The Northwestern Pacific Railroad Acquiring Corp., a California corporation (Sellers) hereby grant to Britt Lumber Co., Inc., a California corporation (Buyer) an option to purchase the real property, including all rights of Sellers to rightsof-way, easements and all other appurtenant rights, together with all improvements located on the rights-of-way, excepting therefrom railroad tracks and ties, which is located in Humboldt County, California, commonly known as all of that portion of a railroad right-of-way which is adjacent to three separate parcels of real property owned by Buyer and described more particularly below and in the option Agreement dated December 5, 1990, between Sellers and Buyer.

1. Property Description. The three parcels of real property, which are designated as **Parcel A, Parcel B** and **Parcel C**, are described in attached Exhibit A and incorporated herein by this reference.

2. Term. The term of the Agreement begins on December 5, 1990, and ends December 4, 2040.

3. Extensions. There are no extensions of this option available to Buyer.

4. Termination. Buyer's interest will terminate at the end of the term unless on or before such date the property has been conveyed to Buyer.

5. Price and Terms. The parties have executed and recorded this instrument for the purpose of imparting notice of the Agreement and the respective rights and obligations of Buyer and Sellers, the terms, covenants and conditions of which are incorporated herein by reference as though set forth fully herein. In the event of any inconsistency between this Memorandum, and the Agreement, the Agreement shall control. This Memorandum and the Agreement shall bind and inure to the benefit of the parties hereto, and their respective heirs, successors and assigns, subject, however, to the provisions of the Agreement on assignment.
