**PURSUANT TO 49 C.F.R. §1180.2(d)(2)**

Pursuant to 49 C.F.R. §1180.2(d)(2), Franklin Storage Co., Inc. (hereinafter “Franklin Storage”), a non-carrier, caused to be filed Verified Notice of Exemption from Board authority

under 49 U.S.C. §1180(d)(2) requesting approval of the Surface Transportation Board to own and operate four Class III rail carriers located and operated in Franklin County, Pennsylvania, which Verified Notices of Exemption under 49 C.F.R. §1150.31 were pending at the time of filing.

Franklin Storage was the incorrect petitioning party in the instant action. Continuance in Control action should have been undertaken and filed by the majority owner of Franklin Storage, Colby Nitterhouse, who is also the majority owner of the proposed carriers which the continuance in control is sought.
