Dear Judge Soulikias and Counsel:

Applicants write to provide an update regarding their production of non-custodial and custodial documents in response to discovery requests in this proceeding and the current status of deposition scheduling.

As of the date of this letter, Applicants have received over **450 discovery requests** (not including hundreds of subparts) from interested parties to this proceeding. The scope of documents, communications, information, and data sought by these discovery requests is unprecedented and far exceeds the needs of this proceeding. Nevertheless, Applicants have been working diligently to identify and produce materials responsive to these requests and to work collaboratively with the non-Applicant parties to resolve disputes over relevance, scope, and burden on a request-by-request basis.

Applicants have produced more than **4 million pages of documents** and more than **3,800 GB of data** in response to discovery requests. These rolling productions have been made on top of the detailed Amended Application and supporting workpapers filed on April 30, Applicants' submissions in response to Decision No. 21 filed on July 7 and July 27, and various other data and documents submitted in response to the Board's requests, all of which the non-Applicant Class I railroads and other interested parties also received. Applicants are also continuing to work with participants to schedule depositions of Applicants' personnel and experts.

Union Pacific and Norfolk Southern provide the following updates on their respective efforts to produce non-custodial and custodial material in this proceeding.

Union Pacific's Update On Productions

Union Pacific continues to search for, collect, and review material stored in non-custodial and custodial locations that may be responsive to discovery requests in this proceeding. Union Pacific has made nine productions (UP 027–UP 035) since Applicants' last update on August 21 and has substantially completed productions for its second tranche of 20 custodians.
